THE CHAIR FOR CONSTRUCTION ENGINEERING AND MANAGEMENT

COURSE DESCRIPTION

A short course in Public Private Partnerships and Procurement will be presented from 10 to 12 February 2016 at the Chair in Construction Engineering and Management of the Department of Civil Engineering at Stellenbosch University .

The Chair aims to develop management practices for managers at all levels and in all spheres of the built environment, be it from the side of the client, designer, contractor or user. It also aims to equip engineers and allied professionals in the industry with some of the necessary background to understand the challenges of the construction environment.

The purpose of this course in Public Private and Procurement is to provide course participants with an understanding of the basic concepts and characteristics of PPP procurement, project financing and the role of the NEC construction contracts in project procurement. By considering the need for appropriate procurement models in South Africa, this course provides a solid background which is needed to understand the applications and limitations of PPP procurement, but also of the role of project financing in infrastructure procurement.

The course starts with an introduction to PPP followed by the characteristics and the regulatory framework in South Africa presented by Dr Nthati Khatleli of WITS. Tony Parker formerly a director of Murray & Roberts Concessions, will provide excellent examples of the applications, advantages and pitfalls of PPP. The course allows interactive discussion in an environment of collaboration and knowledge transfer.

Francois Swart, former founder and CEO of Bigen Africa, will address basics of project finance, starting with principles of financial management and control. He will use his extensive experience in project financing to demonstrate the important principles.

An introduction will be given of the NEC as alternative to other South African procurement contracts. The benefits and applications of NEC procurement will be identified and discussed. The NEC will be presented by Hannes Marais from Saldanah Bay Industrial Zone, and by Chris Jurgens of Stellenbosch University. Together they presented two successful NEC courses in 2015.

The following persons should attend the course on Public Private Partnerships and Procurement:

- Managers, engineers and other persons at local and central government who are involved in planning and management of infrastructure and who need a thorough understanding of the principles involved in Public Private Partnerships and project procurement.
- Managers, engineers and allied professionals at consulting practices involved with the development and initiation of infrastructure projects.
- Managers, engineers and allied professionals at construction companies who work with others in the private sector to initiate projects and develop infrastructure.
- Engineers and allied professionals in organizations that become involved in supporting initiatives for the initiation and develop of infrastructure projects.
